

## Did you know?

#### **Learn About Safety Footwear & ASTM Standards**

The most important protection is to wear the proper footwear for your work and environment. In most agricultural occupations the footwear should provide three major types of protection.

- The soles and heels should be slip-resistant
- The toe of the footwear should resist crushing injuries
- The footwear should support the ankle



#### All DiVal Safety Footwear meets or exceeds the ASTM standards:

ASTM F-2412-11 (Standard Test Methods for Foot Protection) defines the procedures used to test protective toe footwear to the various safety classifications. ASTM F-2413- (Standard Specification for Performance Requirements for Protective (Safety) Toe Cap Footwear) defines the minimum requirements for the design, performance, testing, and classification of safety toe footwear. The following is an example of an ASTM F2413- marking that may be found on protective footwear:

## "ASTM F2413-18 [M] or [F] I/C [EH] or [SD] Mt PR"

Line #1: ASTM F2413-18

It indicates that the protective footwear meets the performance requirements of ASTM F2413 issued in 2018.

Line #2: [M] or[F]/I/C

This line identifies the gender (M [Male] or F [Female]) for which the footwear is intended. It also identifies the existence of impact resistance (I), the impact resistance rating (75 foot-pounds), compression resistance (C) and the compression resistance rating (75) which correlates to 2,500 pounds of compression.



#### **Lines 3 & 4:** [EH] or [SD]/Mt/PR

Lines 3 and 4 are used to identify footwear made to offer protection from other specific types of hazards referenced in the standard. They are used to designate conductive (Cd) properties, electrical hazard resistance properties (EH), footwear designed to reduce the accumulation of excess static electricity (SD) The metatarsal designation (Mt) is rated (75 foot-pounds) is also identified, and puncture resistance (PR) meets puncture resistance requirements.

# Footwear Technology Waterproof:



Insulation: Thinsulation™ insulation material added to the lining in boots to help keep the foot warm and comfortable in cooler environments.



Electro Static-Dissipative: Helps reduce excess static electricity by conducting the charge from the body to the ground.



Puncture Resistant (CSA): Flexible, plate minimizes the likelihood of puncture wounds. Meets US and Canadian safety standards.



Security Friendly: Built with materials that should expedite trips through metal detectors and should reduce the chances of marking or scratching surfaces.



Electrical Hazard:
Provides a secondary source
of protection when outsole
accidentally comes in contact
with live electrical circuits,
helping to reduce the potential of electrical shock. This is
measured under dry conditions
and may deteriorate in wet
environments and with wear.



Oil & Slip Resistant: Outsole is designed to provide a high level of coefficient of friction with the walking surface to improve slip resistance.

## Toe Types:



Steel Toe - Made of steel and epoxy coated to resist corrosion. Thinnest toe cap used in footwear to provide protection for the toe area. Steel toes meet or exceed the ASTM FS2413 standard for protective footwear.



Alloy Toe - Made of lightweight materials like aluminum and titanium. Lightest toe cap 35% lighter than steel. Alloy toes meet or exceed the ASTM FS2413 standard for protective footwear.



Composite Toe - Made of non-ferrous elastomeric materials. Metal free (airport friendly), are 10% lighter than steel & conducts heat and cold slower than steel. Comp toes meet or exceed the ASTM FS2413 standard for protective footwear.



Carbon Toe - 100% non-metallic (airport friendly), lightweight, and unobtrusive fit, are 15% lighter than steel & conducts heat and cold slower than steel. Carbon toes meet or exceed the ASTM FS2413 standard for protective footwear.





- Don't rely on shoe size alone Different brand or even styles will fit differently
- Always stand and walk around in the shoes to see if they are comfortable, fit well, and don't rub anywhere
- You want room for your toes to be able to move freely as this helps circulation and flexibility
- Don't plan on shoes stretching over time.
   They should fit well when you buy them!
